When entering into an agreement with any institution for short- or long-term work, a lawyer or attorney skilled in legal practices pertaining to the arts should review any con-tracts before signing. You can use this contract as a starting point for drafting an agreement for a commission, but do not rely on this contract in its present form and do not sign it until you have had legal counsel look at it and suggest alterations or changes.

## **Artist's Lecture Contract, con't**

No use of this recording (other than for educational purposes) shall be allowed without the written permission of the Artist. Both parties agree that the Artist shall retain the rights to such recordings.

Additional compensation shall be paid to the Artist for any such use.

#### **Insurance**

If artworks are used (instead of DVDs, CDs, or other media representations of artwork), insurance shall be provided for the event, including transportation of works.

Insurance costs shall be covered by the Sponsor and shall be equal in value to a Schedule of Artworks attached to this agree-ment.

### **Packing and Shipping**

In the case that artwork or materials are needed for the Artist's Lecture, costs for packing and shipping shall be covered in the following manner:
